



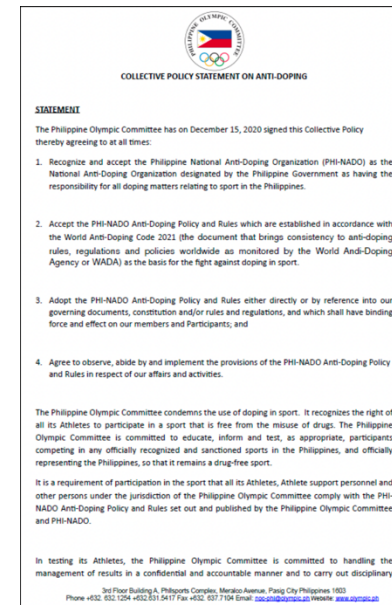
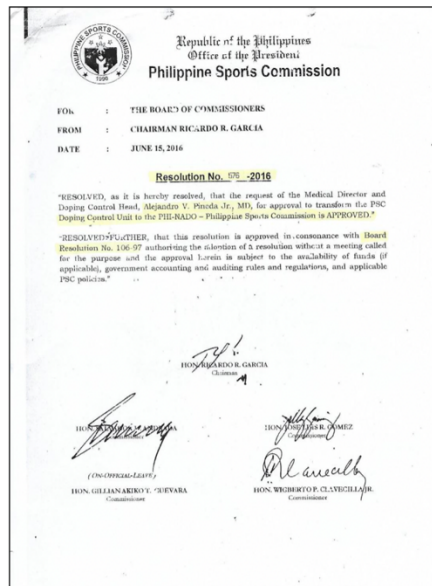

### PHI-NADO ANNUAL STATISTICS FOR 2022

The fight against doping in sports is a global effort of which the Philippines is a signatory starting with the 2003 Copenhagen Declaration on Anti-Doping in Sport, the 2005 UNESCO General Conference, the Ratification of the International Convention Against Sports by the Philippines in 2010, and the full representation and participation of the Philippines in the 2006 Southeast Asia Regional Anti-doping Organization (SEA RADO) – the regional body responsible for implementing WADA doping controls and anti-doping education in the SEA region.

With the board resolution, PHI-NADO has been established as an independent entity with collaborations with the Philippine Sports Commission and the Philippine Olympic Committee:

The set-up and structure of PHI-NADO allow it to accomplish critical tasks under the following work environment set forth by WADA and monitored by SEA RADO:

1. Operational independence
2. Transparency
3. No conflict of interest (as agency or personnel working in the NADO)
4. Professional and cooperative relationships with stakeholders (NOC, High Performance, National Federations, Ministries, ETC)
5. Allocation of budget and independent financial auditors
6. Board (Free from appointments from sports organizations)
7. Independent external advice for cases (legal expertise)
8. Sponsor and external funding for programs
9. Dedicated staff

The entity designated as possessing the primary authority and responsibility to adopt and implement anti-doping rules in the Philippines, direct the collection of Samples, manage test results as well as the conduct of hearings at the national level, and implement designed anti-doping education programs, and undertake social research relevant to anti-doping efforts.

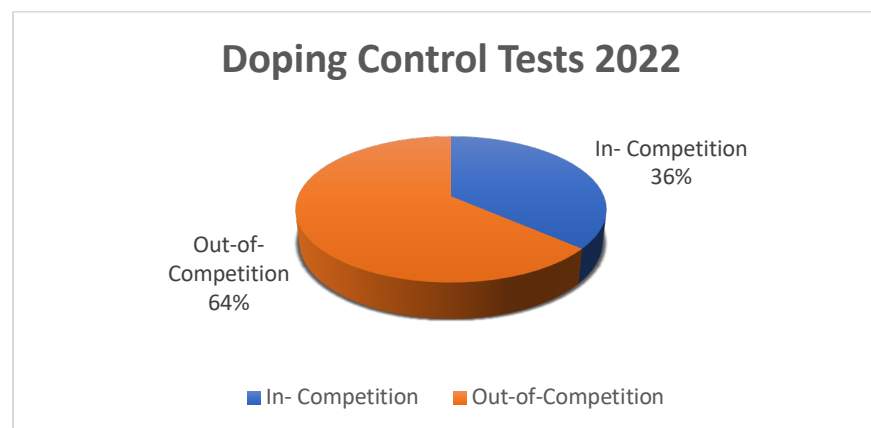
**MISSION STATEMENT:**

To maintain the integrity of sports in the Philippines by:

1. Ensuring fair competition and a level playing field through the implementation of anti-doping policies that comply with the World Anti-Doping Code and its International Standards
2. Protecting the health of Athletes through educational interventions that inculcate the value of clean sport and pursuit of athletic excellence without the *Use of Prohibited Substances, Illicit performance-enhancing drugs, and Methods.*
3. Implement doping controls that respect the right of athletes to participate in a clean play and fair play sports environment.

The 2022 Report summarizes the results of all the samples WADA-accredited Laboratories analyzed and reported to WADA's Anti-Doping Administration and Management System (ADAMS) in 2022. The 2022 Report – which includes this Summary and sub-reports by Sport, and includes in- and out-of-competition urine samples; and the resulting Adverse Analytical Findings (AAFs) and Atypical Findings (ATFs).

In total, **70 doping control urine testing In (40) and Out (30) of the competitions have been conducted for 2022.** It should be noted in the figures 2022 Report, that the COVID-19 pandemic significantly impacted the total number of samples collected and so due to some restrictions, PHI-NADO hasn't conducted blood testing for these statistics.

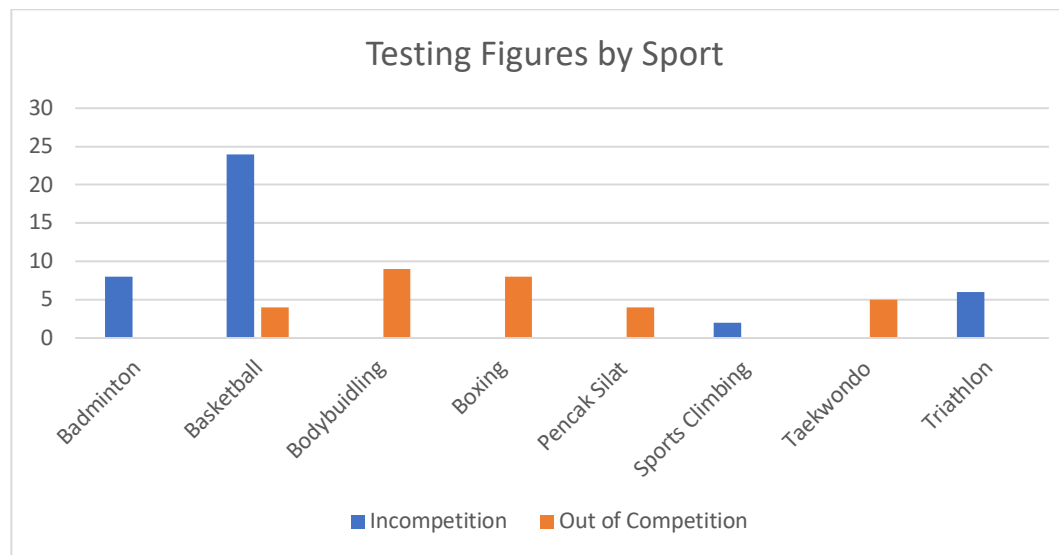

- Bodybuilding – 9 Out of competition
- Boxing – 8 Out of competition
- Pencak Silat – 4 Out of competition
- Sports Climbing – 2 In competition
- Taekwondo – 5 Out competition
- Triathlon – 6 In competition
